#13 Authorize a grant Application be submitted to the Ohio Department of Transportation Office Of Aviation for Fiscal Year 2022 Ohio Airport Grant Program to replace Taxiway C and Taxiway D Lighting.

Engineer:

- Approve a proposal with Burgess & Niple, in amount of \$49,900 to assist with the preparation of the environmental documentation, preliminary engineering, utility coordination and design/build bidding documents for the replacement of Peck Wadsworth Road Bridge No. 0783. Estimated construction cost of this project is \$1,101,000 of which 80% will be funded by the Federal Highway Administration. Funding has been approved for fiscal year 2025 and the county engineer is electing to develop this project utilizing the design/build methodology and will be paid from Acct#eng proj bridge
- Award and enter into a contract with Schirmer Construction, Inc., North Olmsted, in the amount of \$226,772.00 for the Stoney Ridge Rd. Bridge #0424 Rehabilitation project, Avon. 5 bids were opened on April 22, this being the most responsive complying with specifications. Issue Notice to Proceed, beginning on or around July 19, 2021 and completed on or before October 31, 2021; Authorize Administrator to notify Auditor to release retainage at the completion of the project and will be paid from Acct#engineer bridge
- #16 Advertise and receive bids for the 2021 Countywide Chip & Seal Program. Notice to be in the Morning Journal on May 7 & 14 and open at 2 pm on May 25, 2021. This project consists of performing Chip & Seal pavement treatment to approximately 47 miles of County and Township roads throughout Lorain County and estimate cost is \$851,048.60
